Tuition will not be prorated for vacations, missed days, snow days, absences or closures due to COVID quarantine period.

The Language Tree offers three payment options. Regardless of your payment choice, a **\$250 Enrollment Fee is due with this Enrollment Agreement**, and no agreement will be accepted without a \$250 fee. The \$250 deposit will **not** be applied to tuition. Tuition may be paid using one of the following three payment plans. Please initialize your selection.

Pay in full due: 7/31/2023	
Two Payments: 7/31/2023, Second 1/31/24	
Pay in 10 Monthly Payments, first due 7/31/2023	

The Language Tree retains the right to cancel a program if the number of students enrolled is insufficient. The \$250 fee will guarantee a student's place for the entire academic year. Substantially, all of The Language Tree's program costs are used to hire our specialized teachers.

Accordingly, **the above tuition is non-refundable** and payable on the dates indicated for the payment option selected above, even if the student decides not to attend the school, subject to the following exceptions:

- An Applicant may cancel his or her Enrollment Agreement by providing notice to the Director of The Language Tree within five business days of its submission. If canceled, any tuition and supply fee will be refunded within 30 days.
- If the Enrollment Agreement is not accepted or if The Language tree must cancel a program, then the full tuition and the supply fee will be refunded within 30 days.
- If the student decides not to attend and provides notice to the Director before May 1, 2023, then all tuition paid (excluding the supply fee) will be refunded within 30 days.

This Enrollment Agreement is a binding, legal document. Please do not sign it before you read it or if it contains any blank spaces.

You are entitled to an exact copy of the Enrollment Agreement, the Handbook(emailed), and any other papers you may sign. Any changes in this document are not binding, unless the changes are acknowledged in writing by an authorized representative of The Language Tree and by the student's parent/guardian.
